We are eager to begin the registration process for the TWO 2012 art festivals, and we appreciate all of the emails we have received asking about the process. We are proud to be part of the Bicentennial Celebration for the City of Evansville, and we look forward to your participation!

It is our pleasure to invite you to apply for the 3rd Annual Funk in the City Spring Art Festival (April 28 – NOTE: the Spring Art Fest will run from 10am-4pm) and the 10th Annual Haynie's Corner Art Festival (September 29). As always, we will do our very best to make this a fantastic experience for you!

Like last year, **there will be only ONE APPLICATION for both events.** There is a place on the application to select which event you are applying for. If you apply for both events, you will receive a \$10 discount.

Some information for you related to the festivals in 2012:

- 10th Anniversary – this Fall marks the 10th Anniversary of for the art festival at Haynie's Corner. We are excited to celebrate this milestone with you and the community, and we will have more information about a special celebration in the coming months.
- What are we doing with the proceeds? Supporting the arts in our community has been a focus for Funk in the City since day 1. Last year, we launched a very special initiative to engage more inner-city youth in the arts – specifically painting. The beginning of the program has been very successful, and most importantly, the kids at the Boys & Girls Club LOVE the program. Funk in the City is also still in the process of developing the annual dragon boat racing festival, and our goal is to have that event self-sustaining within the next two-three years. In addition to the new youth art initiative, a portion of the proceeds from the art festivals help support our dragon boat racing initiative.
- For new applicants – we give preference to returning artists/vendors. Each year we have a number of available spaces, but it is all determined by the percentage of returning artists. We maintain a waiting list once we have filled all available spaces.

We look forward to hearing from you – the deadline is March 23! As we have done in the past several years, email will be our primary form of communication. Please do not hesitate to contact us if you have questions. We will do our best to respond in a timely manner!

SPECIAL NOTES AND AGREEMENTS:

- **Application Deadline for BOTH EVENTS: March 23, 2012.**
- **All application fees must be paid in full with your application and are non-refundable.**
- **Booth placement – priority is given to returning artists and vendors who participated in 2011. New applicants will be accepted and placed (booth placement) at the discretion of the Art Festival Committee AFTER the application deadline.**
- **Booth Fee is a 15% commission on your gross booth sales and MUST be paid at the end of each Festival.**
- **Artist must provide ALL tables, tent, chairs, shelves, and any other required display items. Displays should remain within the allotted 10' x 10' booth space.**
- **Funk in the City WILL NOT PROVIDE ELECTRICITY!**
